## DESCRIPTION

Workwear bib pants certified according to standards EN ISO 13688, EN ISO 1149-5, and EN 61340-5. The optimal fabric weight ensures breathability and is an ideal choice for manufacturing operations as well as outdoor use. Special fiber lends the garment high durability and strength along with antistatic properties. Functional pocket lines placed into seams eliminate material layering, featuring a design without visible zippers. The trousers are equipped with 2 touch pockets, 2 front thigh pockets, and 2 back pockets. The back section divides the saddle. ADN<sup>®</sup>AdaptBelt technology allows for smooth adjustment of the waist width with every movement without feeling restricted. 1 inner zippered pocket is located on the lacing, elastic suspenders with a buckle for easy length adjustment. Sleek, anatomically shaped 3D SLIM FIT cut with pre-shaped knees, knee area made from doubled material for increased durability. Enhanced user visibility is ensured by reflective strips located on the front and back. The trousers allow easy length extension by 5 cm. The garment is free of metal accessories, designed for industrial laundering.
