## DESCRIPTION

Stretch cotton shorts made from special Amalytton<sup>®</sup> material, which stands out for its increased strength and smooth, fine surface. You will appreciate the reduced weight due to the pleasant sensation when wearing. Durable and four-way elastic Tabiflex<sup>®</sup> is used on exposed areas. The shorts are equipped with an elastic waistband collar along with a hidden back double loop for comfortable belt placement, inner anti-slip tape, D-ring for a carabiner, 2 hand pockets, 1 front zip pocket, 1 front utility pocket with a wide loop. On the right leg, there is a multifunctional pocket for a folding meter, screwdriver, and breakaway knife with wide loops, while on the left leg, there is a large double pocket covered with a snap flap. Triple stitching is present in stressed areas. The back part articulates the saddle, with 2 pockets, the right back pocket covered with a snap flap. Increased user visibility is ensured by dynamic reflective 3D prints and hi-vis accessories.
